___15. Governor Rick Snyder and the Legislature must address a current \$1.8 billion state budget deficit for the next fiscal year, out of a general fund budget of \$7.7 billion. If Governor Snyder's proposal to eliminate the Michigan Business Tax and replace it with a 6 percent corporate income tax is approved, the budget deficit would nearly double to \$3.3 billion, which is 43 percent of the current state general fund budget. Whether the budget deficit is \$1.8 billion or rises to \$3.3 billion with the replacement of the Michigan Business Tax, based on what you know or have heard or read, which of the following statements best describes how you think Governor Snyder and the Michigan Legislature should now act to balance the state budget? [READ AND ROTATE 1 TO 5 BELOW]

- 21% It should **ONLY** be balanced by cuts in programs and services, with no increase in taxes;

Thinking again about the state budget deficit, as indicated before, the \$1.8 billion budget deficit would be increased by \$1.5 billion if Governor Snyder replaces the Michigan Business Tax with a 6 percent corporate income tax, nearly doubling the budget deficit to \$3.3 billion, which would have to be balanced from a state general fund budget of \$7.7 billion. Now I would like to describe two possible approaches to balancing the state budget. [READ AND ROTATE TWO PARAGRAPHS BELOW]

(One/Another) proposal would balance the state budget by approving an all cuts budget that would total \$3.3 billion. This would require deep budget cuts in all state departments, including human services, corrections, natural resources, public education, community colleges and public universities, revenue sharing payments to counties, cities and townships, and requiring cuts in pay and benefits for all public employees – including state workers, teachers and other local public school district employees, as well as police, fire and other workers employed by local governments. It will also very likely require layoffs of state and local public employees, as well as teachers and other local public school district employees.

(One/Another) proposal would eliminate \$2 billion in tax credits, deductions and exemptions that go to Michigan businesses by eliminating those types of special business tax provisions that do not create jobs or protect existing ones. Another \$800 million in revenue could be raised by requiring a five percent reduction in spending on the \$16 billion in state government contracts paid for services. This could be accomplished by eliminating contracts that are not needed, or requiring a 5 percent cut in payments. Implementing these measures would leave \$500 million in cuts that could be made in the corrections budget by making sentencing guidelines consistent with surrounding states and requiring further pay and benefit concessions from state and local public employees.

Which approach comes closer to your view of how best to balance the state budget – the approach that requires an all cuts budget to eliminate the deficit, or, the approach that raises revenue by eliminating corporate tax breaks that do not create or preserve jobs, cutting back on state contracts and requiring more limited budget cuts?
