INTRO TO Q.6: Now I would like to read the actual ballot language of Proposal 1. The title reads -- Amend the state constitution to increase the maximum sales tax rate from 6% to 7%, eliminate the sales and use taxes on gasoline and diesel fuel, dedicate a portion of the use tax revenue to the school aid fund, revise the permissible uses of the School Aid Fund, and trigger other laws that include dedicating revenue for roads and other transportation purposes.

___06. The ballot language goes on to say the proposed constitutional amendment would: Set the maximum sales tax rate at 7% -- it's now 6%. Exempt gasoline and diesel fuel from sales and use taxes. Dedicate a portion of use tax to School Aid Fund. Allow the use of the School Aid Fund for community colleges and career and technical education and prohibit use for higher education. It would trigger laws that include but are not limited to: an increase in the sales and use tax to 7%; increase the motor fuel tax on gasoline and diesel fuel and increase vehicle registration fees, and dedicate revenue for roads and other transportation purposes. Require competitive bidding and warranties for road projects; and increase the earned income tax credit.
